## Revised Advance Lock Policy

Reunion Mortgage has revised our Advance Lock Policy to accommodate the new appraisal ordering process.

Effective May 15, 2009, advance locks will be accepted for conventional loans *only* if an appraisal has been received or ordered by Reunion. An appraisal is considered ordered once payment has been received by our Appraisal Management Company.

Brokers can continue to advance lock and provide appraisals for FHA loans.
